


In 2Q 2020 ENGIE Energía Perú was a leading player of the sector accounting for 19.7% of the total capacity and 11.3% of the total energy generation

- √ We aim to remain at the forefront of the energy transition


Organic growth in different technologies







Financial Debt Evolution




- Minimum payout ratio of 30%
